### 4. First-aid Measures

#### 4.1 Description of First Aid Measures

**GENERAL NOTES:** When symptoms persist or in all cases of doubt seek medical advice.

**AFTER INHALATION:** Move to fresh air. Consult a physician after significant exposure.

### 7.1 Precautions for safe handling

**INSTRUCTIONS FOR SAFE HANDLING:** Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours).
